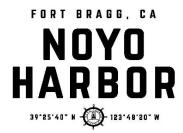

Conduct of Business

1. Discussion and possible action on signage for docks

A discussion was held on signage for the Harbor District. Overall, the commissioners liked the proposed dock signs and Commissioner Downie suggested back lighting, perhaps via solar lamps. A larger conversation on the "Caught in Noyo Harbor" sign was held and Chair Hurst suggested Rick Sacks with the Sign Shop in Mendocino. He does custom wood signs. It was generally agreed that a "Noyo Harbor" sign was preferred to a "Caught in Noyo Harbor" and the sign should match the marina.

Commissioner Downie suggested a bulletin board on the fish cleaning station where information about Dockside sales could be posted and a map of the marina. The Harbormaster is going to look into completing that work.

2. Discussion and possible action on Vessel Demolition Specialist

The potential of hiring a vessel demolition specialist was held, overall the commission liked the idea but a few components needed to be ironed out. Jim Jackson proposed that he look into the labor laws and make suggestions on how to best accomplish this task.

- 3. Discussion and possible action on letter to PMFC
- Commissioner Weaver pasted out information to the board about a proposed letter to the Pacific Marine Fisheries Council and laid out the timeline for submitting the letter. Commissioner Weaver detailed the controversy over the fall runs in the Sacramento. Chair Hurst suggested that the proposed letter but submitted to the Mendocino County Board of Supervisors and City of Fort Bragg prior to approval by the commission. This would allow the letter to move rapidly through various governing bodies to meet deadlines for submittal. Commissioner Weaver and the Harbormaster will proceed and bring back a letter for approval at the February meeting.
- 4. Discussion and possible action on Vessel Acquisition Grants
 Commissioner Weaver led a discussion on potential vessel acquisition. Commissioner Downie,
 Commissioner Weaver and the marina manger Nick Savedra are going to meet to discuss
 potential vessel for acquisition, given a 25% match might be required.
 - 5. Discussion and possible action on Fleet Stakeholder Report

A lively discussion was held on the fleet stakeholder report, including the concept of the Harbor District hosting a fish processing center. Overall it was agreed that significant research should be undertaken before a fish processing center is actually built on Harbor District property. Other finding from the report were discussed and were overall approved of. The commission spoke briefly on what to do with the finds of the report. The Harbormaster suggested that they attach it to grant proposed when necessary to show two stakeholder driven documents that lay out the needs of the commercial fleet.

Motion was made to accept the findings of the Fishermen's Stakeholder Report. 1st Commissioner Shoemaker, 2nd Commissioner Weaver. Approved 4-0-1

6. Discussion and possible action on potential Grant Programs
Discussions were held on the merit of several grant proposals suggested by the Harbor Office.
The largest consideration was between waiting to acquire property in the river for a fuel dock verse establishing fuel on the District's current property. While the Catalyst fund looks to develop fuel on the current property, much could be learned and information transferred to another property if acquisition did occur. The harbormaster agreed to adding market analysis to the fish processing center concept should funding occur.

The Harbormaster will bring back the marina redevelopment application as it develops. A general consensus was reached that the Harbormaster should proceed.

Title: SHN Task Order 5

Recommended Action: Approval or Recommendations

Analysis

The Harbormaster received their notice to proceed from the California Coastal Conservancy for the Marina Redevelopment Planning Project. In the scope of work SHN was listed as contractors who would help the Harbor District complete many of the planning and permitting aspects of the program.

SHN has submitted Task Order 5 to the commission as the first step toward getting this project off the ground. SHN and the Harbormaster would like to work through smaller Task Orders to complete work rather than one large Task Order. This will allow more flexibility in the Task Orders as the project evolves and discrete task with accomplishable outcomes.

The Harbormaster would recommend that we set a due date for this task order to keep the project on track. Overall, the project should be completed in two years. A due date, or at least an expected next Task Order date would also help with budgeting.

Fiscal Impact

Task Order Five is estimated to cost \$85,000. This project is 100% funded

SHN-Noyo Harbor District Master Services Agreement

1. Master Services Agreement

This Task Order represents the mutual agreement of SHN and Noyo Harbor District for the project described below. The Task Order will be performed and controlled under the terms and conditions of the Master Services Agreement between SHN Consulting Engineers & Geologists, Inc. and Noyo Harbor District (421058) dated October 14, 2021.

2. Project Description

- A. The scope of work to be provided by SHN to CLIENT includes all necessary personnel, materials, and equipment necessary to provide Planning, Engineering, Geological, and Biological services for the redevelopment of the District's marina. This scope consists of all planning, engineering, and geological services required to achieve the Project Outcomes described in the District's State Coastal Conservancy Grant.
- B. CLIENT is aware that no work will begin until both CLIENT and SHN sign this Agreement.

3. Scope of Services

- A. The professional services provided by SHN for the above-described project are limited to work scope associated with Planning, Engineering, Geologic, and Biological services as outlined below:
 - (i) Stakeholder outreach—assist NHD as directed in the development of community engagement materials and information.
 - (ii) Agency outreach—develop preliminary project materials to engage with permitting and regulatory agencies with jurisdiction over the project.
 - (iii) Technical studies—identify and complete necessary technical studies required for permit applications (for example, eel grass survey and report, marine mammal survey and report, etc.).
 - (iv) Identification of risk and mitigation measures—consult with regulatory agencies through outreach and after development of technical studies to identify mitigation measures to reduce impacts/effects of project activities.
 - (v) Construction timelines and funding—determine feasible construction schedules based on outcomes of agency consultation and technical studies, and potential funding sources to construct the project.
 - (vi) Develop construction plans and specifications for District use for contractor procurement, including the following deliverables:
 - a. 30% design draft; 30% design final
 - b. 60% design draft; 60% design final

4. Work Schedule

A. SHN will perform the services described in the Scope of Services, in conformance with the following schedule:



(i) Work will be performed on an as-needed basis and as required to meet Noyo Harbor District's timelines and any potential grant deadlines.

5. Fees

SHN will be compensated for these services on a time and expenses basis. Fees are estimated as <u>six hundred twelve thousand dollars (\$612,000)</u>.

Fees DO NOT include Prevailing Wage Rates.

Title: Vessel Demo Specialist

Analysis

Mr. Jackson submitted the following letter to the Harbor Commission on the subject of a hiring a vessel demolition specialist.

Mr. Jackson's recommendation is that we hire a specialist at a lower rate, then rent their equipment from them at a separate rate. The Harbor Office would like to continue to work with Mr. Jackson to develop an equipment rental agreement that would lay out which aspects of the equipment rental fall under District liability and what would happen if equipment breaks during the removal and abatement process.

The Harbor Office has looked into hazardous materials trainings and it seems like it staff would be able to take something online. Perhaps an hazmat identification course, then hazmat removal could be contracted out as becoming a hazmat removal specialist falls outside the District's normal scope of work.

Fiscal Impact

Mr. Jackson letter specifies that the District would be responsible for the labor burden of the employee and the employee would need to fall under workers' compensation policy.

Re: Part-time occasional employee with equipment

Dear Anna:

At the last meeting of the Harbor Commission, I was asked to research the hiring of a specific vessel demo specialist who would be required to provide his own equipment and would work on an occasional part-time basis. I have performed some preliminary research into the issues surrounding such a hire. There is not a lot of information on this somewhat unique employee, although I recognize that such an employee would be uniquely valuable to your district. I have come across a number of issues which should guide us in drafting a contract for such a hire.

First of all, we do not want to refer to this employee as "on-call" or "standby" as those are terms of art in California labor law. In order to address a situation where a number of employers require their employees to be "available," but not working on the clock, California has established regulations which require that on-call or standby hours must be compensated at the rate of at least the minimum wage (which is \$15.50 per hour) and under some circumstances the full wage rate. Examples of these types of employees are restaurant workers who are told they need to be available if the restaurant gets busy, technical workers who are required to be available by telephone if issues arise at locations after ordinary work hours and similar situations. The issue is whether the employee is actually under the employer's control when he or she is not actively working. If the employee is required to be ready to work at instant notice they must be compensated.

To avoid this area of labor law, the vessel demo specialist should be referred to as an occasional employee (one hired on an irregular basis). Such employees are sometimes referred to as casual employees. This type of employment is seen mainly in the area of casual laborers.

The requirement that the vessel demo specialist supply his own equipment raises some additional issues. As a general rule, equipment must be supplied by an employer, except an employee may be required to provide tools customarily required by his trade or craft. See California Industrial Commission Wage Order 4-2001, Section 9(B). This exception is sometimes referred to as the "tool wage law" and requires that the employee be compensated at a rate at least twice the minimum wage (\$31.00 per hour).

In addition, typically an employer is required to reimburse an employee for any business expenses they incur. See Labor Code Section 2802. I believe this would extend to the reasonable value of the equipment he supplies.

Melding these points of law into a contract, I would recommend that an employment contract be prepared which identifies the vessel demo specialist as an occasional part-time employee (without any use of the phrases on-call or standby). A labor rate should be established, together with a reimbursement rate for use of the specialist's equipment. As an employee, the District will be responsible for the labor burden associated with the labor rate (although not the equipment rate). The District would also need to include him in its workers' compensation policy. His wages would be subject to income tax withholding like any other employee.

Someone on the District staff will need to qualify for hazardous materials certification given the type of work involved in vessel demolition. I have not researched this issue in detail, but I note that the website for the California Office of Emergency Services discusses a hazardous materials program and offers a curriculum to train and certify hazardous materials and outreach instructors. I understand that you have a number of contacts at CalOES and perhaps you can reach out to them regarding this issue. I can also perform additional research to assist you as needed.

Thank you for the opportunity to review these issues on behalf of your district. Please let me know if you would like me to review any of these issues in greater detail. As I have mentioned, I am going to be out of the office February 2-20, 2025.

Analysis

Durning a conversation with Santa Cruz Harbor, their Harbor Director spoke highly of the California CLASS investment pool. She stated that the pool had transformed their interest revenues.

Currently the Harbor District has roughly \$1,000,000 invested in LAIF and has an annual increase income of \$45,000. Monthly LAIF reports 4.3-4.5 effective yields. LIAF interests are compounded quarterly and deposited quarterly into the Harbor District accounts.

California CLASS is a Joint Powers Authority investment pool that provides public agencies the opportunity to invest funds on a cooperative basis in rated pools that are managed in accordance with state law with the primary objectives of offering Participants safety, daily and next-day liquidity, and optimized returns.

The CLASS investment pool has similar effective yields as LAIF 4.4-4.5, however deposit's are monthly rather than quarterly allowing account holders to more rapidly compound interest.

The CLASS investment pool, established in July of 2022 has yielded 4.86% since its inceptions and 5.57% in its first full year.

The Harbormaster would like to establish an account with CLASS and deposit a relatively small amount of our savings into the account to attempt to increase interest revenues annually and broaden the Harbor District's investment portfolio.

Fiscal Impact

A slight increase to interest revenues would be anticipated.

Who oversees California CLASS?

Pursuant to the JPA Agreement, the management of California CLASS is governed by a Board of Trustees comprised of eligible Participants of California CLASS. The Board supervises the California CLASS and its affairs and acts as the liaison between the Participants, the Custodian, the Administrator, the Investment Advisor, and all service providers.

Who is eligible to use California CLASS?

California CLASS is open to all public agencies as defined in California Government Code Section 6509.7. California CLASS is a joint powers entity and public agency that is managed by a Board of Trustees comprised of eligible Participants of the program.

How can an eligible entity Participate in California CLASS?

Enrolling in California CLASS is simple. Under the applicable California Government Code, California public agencies may invest in shares of beneficial interest issued by a joint powers authority. After reading the California CLASS Joint Exercise of Powers Agreement and the relevant Information Statements and Investment Policies, public agencies may join the program by:

Reading the applicable Information Statements (<u>California CLASS Prime</u> and/or California CLASS Enhanced Cash)

Completing and submitting the <u>California CLASS Registration Packet</u> to the California CLASS Client Service Team via <u>email</u> or fax at (877) 930-5214.

After the approval of the above documents, your public agency will receive confirmation that your account has been accepted as a California CLASS Participant.

Keep the original forms for your records; all of these forms can be found in the <u>Document Center</u>. If you have any questions, please contact us; we would love to hear from you!

Does Board oversight differ between the California CLASS Prime Fund and the California CLASS Enhanced Cash Fund?

No, the California CLASS Board of Trustees administers and oversees all investment portfolios offered by California CLASS now and in the future.

No, there is no limit to the number of transactions a Participant may execute with the California CLASS Prime Fund or the California CLASS Enhanced Cash Fund.

The Harbor District's Economic Development Department grant titled Noyo Harbor Revitalization has officially been underway for 1 year and has 1 year remaining in the program. The Harbormaster was able to successfully negotiate a new end date of 2/16/2026.

Have developed site plans including electrical and water hook ups

Blue Economy Visioning Resiliency and Implementation Plan Facilities Conditions

Assessment – The Harbormaster will being touring marine planners from a semi local firm GHD around Noyo Harbor to assess the condition of the current facilities. The GHD planners intend to categorize facilities in Red, Yellow and Green categories. Green being facilities at the beginning of their life, Yellow being facilities in the middle of their life and Red being facilities at the end of their life. While planner will focus on Harbor District facilities, they will also look up and down Noyo River to gauge the overall status of properties that line the river as well. Understanding that labeling a property as "Red" could be detrimental to the property value, individual properties won't be called out specifically but a general idea of the state of private properties will be categorized. This assessment falls under the City of Fort Bragg's Blue Economy Visioning, Resiliency and Implementation plan and update of the City's LCP.

National Working Waterfront Conference- Anna attended the National Working Waterfront Conference. It was a great opportunity to see how other, small and large communities, have worked to keep their waterfronts active and working. A large section of the conference focused on workforce development and infrastructure, two aspects of Noyo Harbor that have been the focus of projects recently. The conference is held every 2-3 years and it would be great to get commissioners and the Harbormaster back to the conference the next time its held.

Fish to Fork Program- The Fort Bragg Middle School and Fort Bragg High School will be serving fresh, locally caught fish starting in March. This avenue was developed as part of the EDD grant to expand the markets for the local fishing fleet. Ideally we would work toward serving hook and line caught fish but this is a great start to getting lifelong seafood customers.
